COMMERCIAL COVERAGE

- Doptelet is covered at parity with eltrombopag for the majority of lives at the largest commercial plans and several pharmacy benefit managers³
- Patients who have commercial prescription insurance and who are eligible for the Doptelet Copay Assistance Program may pay as little as \$0 out of pocket per prescription



MEDICARE COVERAGE

- Doptelet is covered for all United Healthcare AARP Medicare Part D patients⁴
- The majority of Medicare patients taking Doptelet pay between \$0 and \$25 in out-of-pocket costs.⁵ Medicare Part D patients who qualify for LIS may pay \$12 per month or less for Doptelet⁶
